In accordance with Article X of the NCHA Constitution and Bylaws, notice is hereby given that the proposed revisions, modifications and/or amendments to the NCHA Constitution and Bylaws attached as Exhibit A to this Notice will be considered and voted upon by the members at this specially called meeting. The Redlined Version included in Exhibit A illustrates the proposed strike outs and additions to the current Constitution and Bylaws with explanatory footnotes referencing the changes that are being proposed for consideration. The Clean Copy included in Exhibit A is the version to be initially considered by the members. The same Exhibit A is slated for consideration by the NCHA Board of Directors in a special meeting of the Board of Directors on November 30. 2019. The only business permitted to be transacted by the members at this special meeting will be to consider the included Exhibit A or revisions,

modifications, and/or amendments thereto, and/or to approve, (disapprove) revise or amend actions taken or not taken by the Board of Directors with regard to the proposals in Exhibit A.
